PRESIDENT'S MESSAGE #1 – I NEED YOUR HELP!

I need your help. The City has done the right thing in going to "virtual" Council Meetings. There is no sense in going to a crowded room for hours to conduct the City's business. The problem is that, according to the Open Meetings Act, the meetings are supposed to be open to the public and take public comments. After years of attending Council meetings and seeing people line up to speak, I find it disheartening that the public is essentially shut out of these virtual meetings. What is even worse is that the Council members can't hear each other and are sometimes cut out of the meeting but are expected to vote anyway. The virtual system the City is using stinks!

What I need your help on is contacting the Mayor, the City Manager and/or your Council person and ask them to do the following:

- 1. Call around to other Cities to see what they are using, somebody must have figured this out.
- 2. Hire a consultant who knows how these systems work
- 3. Set up a system that is easy for the public to use and <u>advertise</u> how to use it. Get the log-in information and dates out to multiple organizations such as the Chamber of Commerce, CAN, Alpha Genesis, and other organizations and Churches that have large mailing lists.

I have been reluctant to write this since we are all going through this pandemic together and trying to figure things out, but this situation has been going on for six months and the City needs to get on top of it. So let's help them by reminding them that Council meetings are not just for the Council members, but for the public as well. We are as much of a part of the system as they are, and we want open and transparent meetings.

PRESIDENT'S MESSAGE #2 – THE ELECTIONS ARE COMING, THE ELECTIONS ARE COMING!

Well, election season is upon us in full blast. Besides the Federal and State Elections, we have our City and County elections. This year it will be different in more ways than one.

The City election will be on the new date of October 17th. The ballots will be mailed to all registered voters in late September and you can return your vote by mail or, if you prefer, vote in person on the date of the election at Chesapeake College on Race Street (instead of Sailwinds, as in previous years). If there are more than two candidates for a particular slot and no one gets 50% plus one, than there will be a runoff on December 5th of the top two candidates. Final filing for the City positions does not end until September 2nd so we still do not know all who might run, but it will be extremely important to review the positions of these candidates.

The Dorchester County Board of Education elections will be held on November 3, in conjunction with the Presidential election and the various State elections (same ballot, voting procedures, and locations). The Board of Education candidates are Phil Bramble and Mike D. Diaz (County Council District 1), Susan Morgan and Philip W. Rice (County Council District 3), and Laura Hill Layton and Voncia L. Molock (County Council District 5). These are also very important elections as they will determine the direction of Dorchester County Public Schools (DCPS) over the next four years.

To help us understand the candidates' positions, CAN in conjunction with WHCP, the Dorchester Chamber of Commerce, and the Dorchester Banner will sponsor three **Cambridge Community Conversations run by and moderated by the League of Women Voters.** The conversations on September 16th and 23rd (Wednesdays at 7 pm) will focus on the Mayoral and City Council positions, and the conversation on October 7th (also a Wednesday at 7 pm) will focus on the Dorchester County Board of Education election. Please mark these dates on your calendars.

The next four years are going to see growth in Cambridge. Projects like the Cambridge Marketplace with its medical center on Route 50, development of the Sailwinds property, the Packing House project, and Pine St. development are all going to be underway, and critical decisions will have to be made by our elected officials. The schools will be facing challenges from COVID-19 in addition to our existing problems with the system.

Electing the right people will be critical to the future of Cambridge, so study the candidates' positions and VOTE!

CAMBRIDGE REAL ESTATE TRENDS

Market Update: Redfin found that a record 27 percent of searchers on its website in April and May looked to relocate, mainly to small towns from large cities.

Given these data, we have heard from local realtors that folks are actively looking for safer (and cheaper) places to which to move. How have these changes affected Cambridge's real estate market? Let's see what the July numbers suggest.

Sales: Currently, according to Realtor.com, there are 84 homes for sale (75 single family homes and 9 condos and townhomes) in the Cambridge area compared with 98 in June. The median sold price in our last issue was \$175K compared with \$215K in this issue's listing. Thus, we saw fewer homes for sale in July, and the sold price higher than in previous months.

For the month of July, according to Realtor.com, 21 single family, townhouses, and condo sales were completed, varying in price from **\$22,000** to **\$895,000**. They are:

Median Sales Price: Given the relatively small number of sales, median sales prices can vary quite a bit from month to month. Since November, 2013, monthly median sales prices have been as high as \$222,000 in February of this year, and as low as \$104,250 in June of 2015, and \$215K in July, 2020.

Home Values: Over the last year, according to Long and Foster, the median home value in Cambridge, MD (all of zip code 21613) is \$209,900. This is higher than the county median home value of \$150,000. The national median home value is \$231,815. Approximately 39% of Cambridge homes are owned, compared to 45% rented, while 16% are vacant.

Conclusion: 21 houses, townhouses, and condos have sold over the last month; the median sales price has increased; and there are fewer homes for sale. The data may indicate that there has been an increase in demand for homes in Cambridge, potentially a good sign for the value of homes located here.

Real Estate Fun Fact or Fiction: William Kidd, also known as Captain Kidd (c. 1655 – 23 May 1701) was a Scottish sailor who was eventually tried and executed for piracy after returning from a voyage to the Indian Ocean. LOCAL CORONAVIRUS INFORMATION

The best resource we have found for up-to-date, local information about the Coronavirus is the Maryland Department of Health Coronavirus website at http://coronavirus.maryland.gov/. The site includes a dashboard with the most current statistical data from every Maryland County, as well as information on symptoms, resources, and frequently asked question.

Covid-19 Update: According to the latest statistics from the Dorchester County Health Department (as of August 14, 2020), there were a total of 34 active cases in the County, with two persons hospitalized. In our previous report (June 23rd), there were just 13 active cases and only one hospitalized.

Marylanders are advised to take precautions to slow the spread of COVID-19, as follows:

- Wear a mask in public
- Practice social distancing •
- Wash your hands often with soap and water
- Cover your mouth and nose while sneezing or coughing and avoid touching your face
- Avoid contact with sick people, and if sick, stay home and call your health care provider
