<u>Speaker 1</u>. The speaker has a child attending South Dorchester K-8 and asked why certain children are still being quarantined and required to wear masks.

<u>Speaker 2</u>. (a) The speaker questioned why one neighboring county had three minority applicants for superintendent, one of whom was hired, and another neighboring county has recently hired a minority candidate as assistant superintendent, but Dorchester County cannot seem to find qualified minority candidates. The superintendent should be required to explain why minority candidates have not been identified here, but are being identified and hired in neighboring counties. (b) The speaker questioned why DCTC is operating so far under capacity. The speaker challenged the Board members to address these issues forcefully.

<u>Speaker 3</u>. The speaker stressed that representation of minorities in the school system is essential but is severely lacking. Minority children are dying and minority children are being disproportionally affected by violence and trauma, but are not being represented equitably or adequately within DCPS.

<u>Speaker 4</u>. The speaker is a student at Sandy Hill elementary school who today experienced inappropriate actions from another student during gym class. Another student was also treated inappropriately. The gym teacher was working with other students at the time, did not witness the behavior, and thus was not able to intervene. The superintendent promised to pursue this incident with the school.

<u>Speaker 5</u>. The speaker recounted issues raised by parents and teachers at Sandy Hill indicating that administrative support at the school is insufficient and needs to be addressed quickly and meaningfully.

<u>Speaker 6</u>. The speaker, who has a son about to graduate from C-SD High School, indicated that positive changes are needed to address the disruption and bullying in the schools that have increased markedly since her child attended middle school.

## 5. Items for Information

- 5.01 Weapons Detection System Update Chris Hauge, Facilities and Schools Safety Planner. Implementation has been successful and has been completed. Each school required two days for practice and deployment. Electronic contact systems are being developed for notification of school administration, central administration, and first responders, as appropriate. The system collects data from every person passing through, records threat objects vs benign objects, and aggregates the data for each school. Students and staff have been very supportive about the system. DCPS is the only school system in Maryland to implement the system and the first school system in the county to integrate the system with its camera system.
