**EXCLUSIONS:** Major floor prep, removal of contaminants, moving of equipment and furniture, moisture mitigation, grinding, leveling, polishing, sealing, waxing, cleaning, and protection.

Employment of Sex Offenders and Other Criminal Offenders. Company shall complete a criminal background check for each employee prior to any such employee entering Customer

property where students are typically present. Company is aware of and agrees to comply with Section 6-113 of the Education Article ("ED") and Section 11-722 of the Criminal Procedure Article ("CP") of the Annotated Code of Maryland. Pursuant to ED § 6-113(b), Company may not knowingly assign an employee to work on school premises with direct, unsupervised, and uncontrolled access to children, if the employee has been convicted of a crime identified in ED § 6-113(a). Pursuant to CP §11-722(c), a person who enters into a contract with a county board of education may not knowingly employ an individual to work at a school if the individual is a sex offender registry registrant. Notwithstanding anything to the contrary in this Agreement, Company understands and agrees that violation of these provisions may result in immediate termination for cause, and that in such case: (i) Customer shall have no further obligations, monetary or otherwise, to Company; and (ii) Customer shall be entitled to a refund of all monies paid to Company up to the date of Company's breach, payable within thirty (30) days of the breach, except for a pro rata deduction of the fair market value of services actually rendered by Company to date. DCPS shall have the unilateral authority to prohibit a particular employee of Company from performing services under this Agreement if, in the sole discretion of DCPS, the employee has engaged in conduct which would warrant suspension or termination for cause of DCPS's employees under Maryland law.
